Features of admission for foreign citizens and stateless persons

- 89. Foreign citizens and stateless persons have the right to receive higher education at the expense of budgetary allocations in accordance with international treaties of the Russian Federation, federal laws or the quota established by the Government of the Russian Federation for the education of foreign citizens and stateless persons (hereinafter the quota for the education of foreign citizens), as well as at the expense of individuals and legal entities in accordance with agreements on the provision of paid educational services.
- 90. Admission to study within the quota for education of foreign citizens is carried out in accordance with the directions of the federal executive authority responsible for the development of state policy and legal regulation in the field of higher education. Enrollment within the quota for the education of foreign citizens is issued by a separate order (orders) of the organization.
- 91. Foreign citizens who enroll in training on the basis of international treaties, in addition to the documents specified in paragraph 46 of the Admission Rules, submit documents confirming their assignment to the number of persons specified in the relevant international treaties.
- 92. Foreign citizens and stateless persons who are compatriots living abroad (hereinafter referred to as compatriots), in addition to the documents specified in paragraph 46 of the Rules, submit originals or copies of documents provided for in Article 17 of Federal Law No. 99-FZ of May 24, 1999 "About State Policy of the Russian Federation towards Compatriots abroad".

Special rights do not extend to compatriots when applying for bachelor's degree and specialty programs provided in accordance with Federal Law No. 273-FZ, unless otherwise provided by an international treaty of the Russian Federation.

93. Applying for bachelor's degree programs and specialty programs under contracts for the provision of paid educational services, the University

independently establishes a list of entrance exams for foreign citizens and stateless persons.

94. If the number of entrance examinations established for foreign citizens differs from the number of entrance examinations specified in paragraphs 15-17 of the Admission Rules, the University independently allocates the number of places for admission based on the results of entrance examinations established for foreign citizens and conducts a separate competition for these places.

Foreign citizens and stateless persons may, at their choice, enroll in training based on the results of entrance tests established for foreign citizens, or according to the results of entrance tests specified in paragraphs 15-17 of the Admission Rules.

- 95. Applying for admission to the University (in Russian), a foreign citizen provides the following documents in accordance with paragraphs 44-47 of the Admission Rules:
- an identity document of the applicant, or an identity document of a foreign citizen in the Russian Federation (a passport of a foreign citizen or another document established by federal law or recognized in accordance with an international treaty of the Russian Federation as a document certifying the identity of a foreign citizen; a document issued by a foreign state and recognized in accordance with an international treaty of the Russian Federation as an identity document of a stateless person; temporary residence permit; permanent residence permit; other documents provided for by federal law or recognized in accordance with an international treaty of the Russian Federation as identity documents of a stateless person);
- an original document of a state sample on education or its copy certified copy, or an original document of a foreign state on the level of education and qualification recognized in the Russian Federation at the level of a state sample document or its certified copy as well as in cases provided by the legislation of the Russian Federation, a copy of the certificate of recognition of this document;

- a document of a foreign state on the level of education, translated into Russian and certified in accordance with established order and (or) qualifications and its appendices (if it is provided for by the legislation of the state in which such an education document was issued);
- copies of documents or other evidence confirming belonging to compatriots living abroad;
- a copy of entry visa to the Russian Federation, if a foreign citizen arrived in the Russian Federation on an entry visa;
- a copy of the migration card (for citizens of distant foreign countries);
- a 3x4 photo.

The surname, first name and patronymic (in the presence of it) of the applicant indicated in the translations of the submitted documents must correspond to the surname, first name and patronymic (in the presence of it) of the applicant, indicated in the entry visa.

96. Admission of foreign citizens and stateless persons to educational programs containing information constituting state secret, is carried out within the limits of quota for the education of foreign citizens in compliance with the requirements established by the legislation of the Russian Federation on the state secrets.
